Note: Add-on charges include all charges imposed by federal and state law, as well as all charges for third-party collection, are reflected in the amounts shown in sections A and B. These pass-through charges are for: Yolo County Criminal Justice, Courthouse and State Courthouse construction funds; fix-it state fees; state Department of Motor Vehicles collection fee; and vendor processing fee within the state and collection fee for out of state.

C. DELINQUENCIES – BASIC PENALTY:

A one-time late penalty of \$13.00 shall be added to each delinquent parking violation fine at the time the delinquent notice is issued, which shall be no sooner than fifteen (15) consecutive days from the violation date. This penalty includes \$3.00 charged by the state Department of Motor Vehicles as a collection fee.
